Dear Mr Jones

Thank you for your letter regarding the intersection of Womma Road and Stebonheath Road.

I am advised by the Department of Planning, Transport and Infrastructure that the intersection of Womma Road and Stebonheath Road has been identified for improvement and as part of the Eyre at Penfield property development. An agreement has been reached with the developers to upgrade the intersection to include the installation of a roundabout and additional lighting. While a roundabout is the preferred treatment to improve road safety at this intersection, the timing of this upgrade will be guided by the progress of the development.

The department has also explored options to construct the roundabout to a PBS Level 3 Standard, which will facilitate heavy vehicle access to the Greater Edinburgh Parks industrial area. However, these improvements are currently unfunded. Please be assured that this intersection remains a high priority and the department will continue to monitor traffic management at this location.

I trust this information is of assistance and I apologise for the delay in responding.
