#### 8.1 CEO REVIEW SERVICES SELECT REQUEST FOR QUOTE (RFQ) SHORTLIST

#### PURPOSE

For the Chief Executive Officer Review Committee (the Committee) to receive presentations and ask questions of the shortlisted agencies regarding their submission responses to the select Request for Quote (RFQ) for the services of an agency to assist the Committee and the CEO, with CEO review services. This will enable the Committee to consider the shortlisted agencies, with a view to selecting a preferred provider, subject to appropriate reference checks.

#### **EXECUTIVE SUMMARY**

Following the select Request for Quote (RFQ) process seeking an agency or consultant to assist the Committee and the CEO, with CEO review services, the Council evaluated the five submissions received and shortlisted two agencies to present to the Committee for consideration as the preferred service provider.

#### 1. BACKGROUND

At the Committee meeting held on 28 October 2019, the Committee endorsed the Chief Executive Officer Review Services Tender Scope and resolved to undertake a select Request for Quote (RFQ) to the following agencies:

- UXL Consulting;
- Ashby Magro;
- Kathryn McEwen;
- Paula Davies;
- Morton Phillips;
- EGM;
- Perks People Solutions; and
- Local Government Association (LGA) SA;

for the provision of CEO review services for an appointment term of three years plus two years.

The selected agencies were contacted on 31 October 2019 inviting submissions to the RFQ for CEO Review Services. The tender period closed at 2:00pm, Friday 15 November 2019. Five submissions were received from selected agencies. Kathryn McEwen, UXL Consulting and Paula Davies did not submit a response.
