#### **COUNCIL RESOLUTION**

- 1. Council endorse the increase in budget for the design and construction of a Multideck Car Park to be built on Site 7 of Stage 1 of the Northern CBD Project (northern corner of Main North Road and Philip Highway intersection) from a cost of \$7.4m with \$5,939,200 contributed by Council, to \$8.5m with \$7,086,000 contributed by Council.
- 2. Council include \$8.5m capital and \$534,000 annual recurrent funds as part of the Budget Review 1 in November 2017.
- 3. These funds are to be borrowed from LGFA and repaid with funds received as allotments within the Northern CBD Stage 1 precinct are sold.
