8 QUESTIONS WITHOUT NOTICE

8.1 ROUNDABOUT AT THE INTERSECTION OF CURTIS/HEASLIP ROAD (Cr Clint Marsh)

With respect to the proposed roundabout at the intersection of Curtis/Heaslip Road could the following questions be answered using the most recent communication from the Department for Infrastructure and Transport:

Question 1: When is it anticipated that detailed design and final costings for the dual lane roundabout will be completed?

Answer: Mr Dineen advised that detailed design and final costings have been completed for the dual lane roundabout.

Question 2: Is there sufficient deed funding to cover the cost for the dual lane roundabout?

Answer: Mr Dineen advised that there isn't sufficient deed funding to cover the cost for the dual lane roundabout. The scope and therefore the funding of the deed intervention is limited to a single lane roundabout only. Investigations undertaken during the design process identified the need for a dual lane roundabout.

Question 3: If there is insufficient deed funding available within the 2023/24 financial year to commence construction, will the Department for Infrastructure and Transport debt fund the project?

Answer: Mr Dineen advised that the Department of Infrastructure and Transport need to find a funding pathway outside of the deed through their regulatory budget processes for the cost difference.

Question 4: When did the Minister last review and approve a revised four year growth infrastructure schedule?

Answer: Mr Dineen advised that The Minister approved the current four year rolling schedule in late November 2023.

Question 5: Which financial year was it that construction would be funded under the recently approved four year rolling schedule?

Answer: Mr Dineen advised that the four year rolling schedule allocates the deed funding in the 2023/24 financial year.

Question 6: Does the Department for Infrastructure and Transport foresee any reason why a further delay to construction may be experienced?

Answer: Mr Dineen advised that the Department for Infrastructure and Transport would need to confirm this, however his understanding is that the funding pathway is the principle cause of delay.

Question 7: Has the City of Playford met their obligation under the deed arrangement to date? If not what is outstanding?

Answer: Mr Dineen advised that the City of Playford has met their obligation under the deed arrangement to date. Whilst the stormwater solution for the roundabout will benefit from the Broadacres Drain once constructed, through detailed design staff have worked with the Department to enable an interim drainage solution.
