The Rotunda location was designed to facilitate all-abilities access via the footpath network in Fremont Park, including from the new car park on Yorktown Road.

The area behind the Rotunda is the turfed events space which will make a picturesque backdrop for community members using the rotunda for functions.

The dog parks are located north of the Rotunda, behind mounding specifically designed to obscure the view from the Rotunda.
