### **History**

Cr Smallwood-Smith asked the question below, without notice, at the Ordinary Council Meeting held on Tuesday, 27<sup>th</sup> June 2023.

#### Question

Could Council be provided with the number of homeless people in the City of Playford?

# Answer

An internal working group has been established and meets semi-regularly to discuss the emerging issue of homelessness in the city. Staff from Security, Regulatory and Community Safety, City Operations and Connection and Inclusion work together to share information where individuals sleeping rough are identified. Through this information sharing, the administration is aware of approximately 8 rough sleepers within the City of Playford.

Staff that have interactions with individuals sleeping rough provide encouragement towards homelessness assistance services offered in Playford by Anglicare Elizabeth, however, individuals need to 'self-refer' to access this support.

- Focus on maintaining Kooranowa and Duncan Anderson Reserves to a district standard that supports little athletics and transition to adult competition.
- Council acknowledges that Bridgestone Park is the Northern Adelaide Regional athletics facility.
- Council will only progress development of a full synthetic track subject to the outcomes of a feasibility study that considers the capital and ongoing operating costs. The feasibility study will consider external funding opportunities.
- Council will investigate some use of synthetic surfaces when facilities are upgraded (i.e. for a four lane 100m track similar to other district athletic facilities in Adelaide).
- Future need for facilities will be monitored and considered in growth areas as a new facility or school site.
- 2. Include Indoor Cricket on Page 37 in the first column of the table under the heading of Indoor Sports in the Sports Facility Strategy.
- 3. That the CEO is authorised to make minor amendments to the Sports Facility Strategy that do not alter the intent of the Strategy.
