Can the administration provide an update on:

- The completion date for the One Tree Hill Road upgrade?
- Why the 40km/h speed limit is still in place and when will the 40km/h limit be removed?

Answer

Works are largely complete on One Tree Hill Road and the 25kmph speed restrictions have now been raised to 40kmph.

The 40kmph speed restrictions remain in place pending the installation of guard railing. Guard rail is one of the construction items that is currently experiencing longer than usual lead times and delivery is expected in 6 weeks (end of October) for installation in the two weeks thereafter.

Guard rail is to be installed at various locations from approximately CH 00 to CH 2500 (almost the full length of the project) and the Shillabeer intersection is located at CH 2700. The widening works at the Shillabeer intersection have been completed, with the line marking to be completed late next week (due to the rain forecast at the beginning of the week).

Due to the spread of the guard rail locations along One Tree Hill Rd it is not possible to have intermittent sections of the road posted at 80kmph, however once the Shillabeer intersection line marking is complete, the work zone can be shortened slightly.

Please note the speed restrictions are there for people's safety and will remain in place until the guard rail is installed.

Can the administration please confirm details of correspondence sent to and received from the Department of Infrastructure and Transport in relation to Council Resolution 4728?

Answer

The Chief Executive Officer sent a letter to the Department of Infrastructure and Transport (DIT) on the 6 September 2021 requesting an assessment and upgrade to the Blacktop Road and Yorktown Road intersection in One Tree Hill for improved safety by delivering:

- Improved signage.
- Lighting of the intersection for improved visibility.
- Left-hand turning lane on Yorktown Road for vehicles turning left onto Blacktop Road and a merging lane on Blacktop Road.
- Guard railing on Blacktop Road.

To date a response from DIT has not been received.
