8 QUESTIONS WITHOUT NOTICE

8.1 PROPOSED BRIDGE CONSTRUCTION (Cr Peter Rentoulis)

Question: On Sunday the 23rd of September at 11.00am, I attended a public meeting organised by Shaun Reardon at the end of Crittenden Road, Andrews Farm in relation to the proposed bridge construction connecting Smithfield Plains and Andrews Farm. The majority of residents who attended complained that they were not provided any form of public consultation in relation to the proposal. What is the history of the proposed extension, who is funding it and why were the directly affected residents along Crittenden Road on both sides not consulted? Is there a plan to provide public consultation?

Answer:

Mr Pollock advised the bridge construction project is a part of Playford Alive, the joint venture between the City of Playford and the State Government. A masterplan was developed in 2007 as part of Council's capital contribution of \$20M throughout the life of the project.

Community consultation included the distribution of 800 newsletters, and 1100 people participated in community consultation workshops between June and August 2007.

Council is now delivering the capital projects outlined in the masterplan. This \$1.5M project was approved as part of Council's 2018/19 budget and business plan, and includes Special Local Roads Grant funding.

98 residents on Crittendon Road were sent letters advising of the process to date, advising that Council was in the detailed design phase and going out to tender for construction later in the year.

Question: What is the position of the Playford Alive Community Reference Group in relation to the proposed bridge construction connecting both sides of Crittenden Road? When did the Reference Group come to this position?

Answer: Mr Pollock advised the Playford Alive Community Reference Group is an advisory group with no formal powers to approve or endorse Council works. Playford Alive Community Reference Group members have provided positive feedback and are keen to see

the Playford Alive projects being delivered. Currently, there is no formal way that information from Community Reference Group is fed back to the Chamber.

8.2 LGA BUSINESS PROGRAMS (Cr Denis Davey)

Question: Will Council join with the LGA on their new business programs like legal fees, to help reduce costs to Council?

Answer: Mr Hemmerling advised that Council has only just received information on these proposals – they will be reviewed and analysed and a determination will be made.

Question: Thought it would be best practice to engage directly with the small group that have concerns, to hear what they are - why would we not engage with them directly?

Answer: Mr Hemmerling advised that we will follow community consultation policies and processes. The feedback received so far has been documented. If there are further concerns about the design and construction of the bridge we will listen to those concerns.
