Overview of Parks and Reserves



Parks and reserves are planned and designed to deliver quality and sustainable recreational areas which will cater for current and future population needs.

Parks and reserves are areas of open space of varying sizes from small minor parks which cater for local residents in their vicinity to large regional parks which attracts visitors from across the City and outside of the Playford area. They are primarily designed as informal and passive recreational areas which offer a range of amenities to encourage social, inclusive and active community interactions.

Some parks and reserves may also incorporate a drainage or stormwater management function, be part of a wetland or within a sportsground. They may also include service infrastructure such as SA Power Networks transformers or SA Water pumps.

Some of the amenities might include play equipment, BBQ's, walking and cycle paths which provide linkage between open spaces or community facilities, exercise equipment, landscaping and grassed areas, seating and shelters.

Purpose for Which the Land is Held

The purpose for which the land is held to:

- Ensure accessible open spaces for the use, enjoyment, and benefit of the community.
- Inclusive space for all to play, socialise, exercise, celebrate or participate in other community/civic events or sport and recreational activities.
- Encourage social interaction and connection.
- Include playspaces, structured gardens and open grassed areas and nature spaces which provide a setting which people can enjoy.
- Protect and enhance locally native flora and fauna.
- Plant and maintain primarily locally native trees for canopy development.
- Facilitate use of land for utilities and service provider infrastructure.

Management Proposals for the Land

Council will manage development and maintenance of parks and reserves in accordance with all legislative requirements and Council's strategic documents which include the Strategic Plan, city-wide strategies, the Strategic Asset Management Plan and applicable masterplans.

Council's strategic documents are updated periodically. They provide guidance for the planning, management and decision making for Council's community land. A full reference list of the legislative requirements and strategic framework documents is contained within the Community Land Management Plan (CLMP) Overview.

Any proposals which are identified for any of the parks and reserves are subject to Council approval and available funding (grant funding or Council financed).

Overview of Parks and Reserves



Each parks and reserves schedule may contain individual proposals for future upgrades or redevelopment of a park or reserve or associated amenities to enhance the location such as toilets or car parks.

The review of the CLMP considers upgrades which have been undertaken and completed since the last review. Therefore, some parks and reserves have been given a higher classification i.e. a local park has been upgraded to be classified as a neighbourhood park.

Council's key strategic management objectives for parks and reserves include:

- Adoption of a hierarchy approach for the provision of parks and reserves as outlined in Council's Open Space Strategy.
- Provision and maintenance of diverse and quality open space.
- Quality parks and reserves at key locations which provide easily accessible amenities which meets the needs of the local community and visitors.
- Protecting and retaining native vegetation and natural amenity spaces.
- Enhance open space through sustainable and efficient management practices.
- The Strategic Asset Management Plan which identifies strategies to improve management practices that will deliver assets that serve our current and future community.

Parks and Reserves Hierarchy

A hierarchy approach has been adopted through Council's Open Space Strategy for the provision of parks and reserves.

The purpose of creating a hierarchy is to provide a guide for the type of park or reserve to meet the needs of the catchment area; to aim for a maximum distance a user may travel to visit the park or reserve. The hierarchy is influenced by the size, quality and range of facilities provided in any given reserve.

Within this plan, park and reserves have been grouped into their hierarchy level and provide property and ownership details (including Crown land dedicated to Council), maps, the purpose for which the land is held, any management proposals and any specific leases or licenses held over the land.

There may be occasions where a land parcel has multiple community land categories, referred to as "dual categories." For example, the land parcel for the Spruance Road Reserve also incorporates the Playford Tennis Centre, which is included in the Sportsgrounds CLMP. This CLMP applies only to that portion of land categorised as a park or reserve. The remaining area will be covered by the appropriate plan for that category.

Below are the five hierarchy levels and definitions which have been used for the Parks and Reserves CLMP:

- 1. Regional
- 2. District
- 3. Neighbourhood
- 4. Local
- 5. Minor



Overview of Parks and Reserves

1. Regional Parks and Reserves

- Destinations that will potentially draw visitors from across the City and outside of the Council area.
- Provide a focal point in the region due to the size, unique character or diverse features of the park or reserve.
- Include multi-functional spaces that accommodate a range of recreational activities.
- Have the capacity to cater for a large number of visitors.
- Are capable of hosting major events and gatherings.
- Include mature trees and quality landscaping.
- Connect to public transport and/or major roads.

2. District Park and Reserves

- Cater primarily for the local community, with some spaces attracting visitors from across the City and outside of the Council area.
- Provide an appealing and good quality recreational setting.
- Include diverse facilities and activity opportunities for a range of users.
- Include good quality landscaping and tree canopy.
- Capacity to support large number of users linked to activities and events.

3. Neighbourhood Park and Reserves

- Cater primarily for the local community located within a close proximity.
- Provide a focus for local recreational activities such as dog walking and children's play areas.
- Be of good quality and appealing landscaping and provide tree canopy.
- Potential link to local schools and community facilities.

4. Local Parks and Reserves

- Cater for the local community located within walking distance.
- Typically used for short periods of time.
- Could include landscaping and maintained areas and provide tree canopy.
- Contribute to the visual amenity and character of the locality.

5. Minor Parks and Reserves

- Minimal recreation value due to their size and limited recreation function.
- Contribute to the visual amenity, character of the locality, serve as a pedestrian connection and provide tree canopy.

Leasing, Licensing & Permits

General information regarding Council granting of a lease, licence and casual hire permits over community land is contained within the CLMP Overview.

Lease, licence or permit agreements may be granted which are consistent with this plan. In the case of Crown land, the agreement must also be consistent with the dedicated purpose of the land.

Granting of a lease, licence or permit, as per the conditions set out in Section 200 and 202 of the *Local Government Act 1999*, approves the use of parks and reserves, or associated buildings and infrastructure by appropriate tenants including clubs, community groups, schools, commercial/private organisations or community members.

Details of current lease or licence agreements are included in the Community Land Register available on Council's website.

The following types of agreements may be granted over parks and reserves:

• Licence Agreement

A licence agreement (non-exclusive) may be granted which is consistent with the purpose of the land set out in this plan for community or commercial use.

Group Fitness and Personal Training Hire Permit

Permits may be granted for personal training or group fitness classes to be held in Council's parks and reserves. Applicants are issued a permit up to 12 months for set times and locations and must follow specific terms and conditions.

Casual Hire Permit

A casual hire permit is used for single use or short-term use of park or reserve and generally granted to clubs, schools, commercial and community groups. A hirer must comply with the specific terms and conditions.

Permitted casual use includes:

- Personal training and group fitness classes
- Community events
- Commercial or private events
- Council use for community and civic events

Objectives, Targets and Performance Measurement

Council is required within the CLMPs to set out its vision for the land through objectives and performance targets, and how Council proposes to measure its performance against its objectives and targets.

Appendix A sets out the objectives, performance targets and measures for parks and Reserves.





Regional parks and reserves are characterised by their size and diversity and have a catchment area which covers a broad geographical area with visitors travelling from across the City or outside of the Council area.

Regional parks and reserves will usually comprise of a substantial recreational area with numerous amenities and significant areas of natural land which may comprise bushland, wetlands and/or other natural features.

The parks and reserve within this hierarchy include areas large enough to accommodate a variety of concurrent activities such as casual sport, picnics, BBQ's, family gatherings, community/civic events and walking and cycle trails.

The following parks are categorised as regional:

- Fremont Park
- Jo Gapper Park
- Playford Alive Town Park
- Stebonheath Park

Facilities and amenities within a regional park may include:

- Playgrounds/playspaces
- Public toilets
- Trees and landscaping
- May include larger areas of natural habitat (large trees, local native vegetation), remnant vegetation and areas of revegetation
- Irrigated grassed areas
- Entry statement and signage
- Other activity structures i.e. basketball courts, exercise equipment, skate/BMX and soccer goals
- Seating
- **Shelters**
- BBQ's
- Pedestrian and cycles paths
- Community and civic event spaces i.e. rotunda, large open spaces to erect marquees
- Park lighting
- On-site car parking
- Dog parks

Purpose for Which the Land is Held

The purpose for which the land is held is to:

- Provide open space for the use, enjoyment and benefit of the community.
- Be inclusive for all to play, socialise, exercise, celebrate or participate in other community/civic events or sporting and recreational activities.
- Encourages social interaction and connections.
- Include play spaces, structured gardens, open grassed areas and nature spaces which provide a setting which people can enjoy.



Management Proposals for the Land

The eastern portion of Fremont Park was upgraded during 2022/23 to feature a new dog park, expanded events space with irrigated lawns, extension to the fitness loop path, a new gazebo and amenities including off-street parking and public toilets.

Fremont Park



Originally known as the Town Common, the park opened in 1978 with the completed lake, landscaping and car park. In 1980, 25 trees were planted to commemorate each year since Elizabeth's inauguration in 1955.

The park was officially named Fremont Park after the Elizabeth Council's sister city of Fremont, California USA. Some of the oldest trees in the park come from seeds given to Elizabeth Council from the civic leaders of Fremont.

Fremont Park is Council's premier regional park featuring the City's most beautiful recreation and leisure activities. The 15-hectare park features a large lake with fountain, small waterfall and natural creek, extensive green areas, two playgrounds, exercise equipment and a rotunda for events. The park is also a popular location for large community and civic events.



Jo Gapper Park



An English migrant of the 1950s, Jo Gapper OAM was the first elected Mayor of Munno Para Council. After becoming widowed in 1974, Mrs Gapper threw herself into a life of community service, including spending 15 years on Council, with ten as Mayor. She cofounded the Greening of Munno Para Group (now Playford Greening and Landcare Group) and participated in the development of the Munno Para Shopping Centre. Mrs Gapper received the Order of Australia Medal in 1987.

Jo Gapper Activity Park is one of the jewels in the crown of Playford's parks, reserves and playgrounds. Fitting neatly into all three categories, the park features a children's playground, sporting facilities, including football oval, basketball and tennis courts, walking trail and lookout, extensive natural areas and a spacious off-lead dog park.

Playford Alive Town Park



Playford Alive Town Park was named after the 2003 State Government housing initiative to revitalise and develop housing within the Peachey Belt of Smithfield Plains and Davoren Park, and a new housing development within the Munno Para area.

The Town Park is a place the community can come together to enjoy the open grassed areas with picnic areas, playspaces which including water play area and basketball court. The skate park is popular with youth and skating events are regularly held at this location.

Stebonheath Park



Stebonheath Park is home to one of Council's largest wetlands, boasting 3.6 hectares of wetland, boardwalks, and bridges to provide the best views of the park and northern Mount Lofty Ranges.

Stebonheath Park has three distinct playgrounds suitable for toddlers, young children and older more adventurous children with BMX bike ramps and dirt track.

A feature within Stebonheath park is the Stolen Generations Memorial and Healing Garden. This is a place of remembrance, reflection and respect towards Aboriginal people and their families and communities. Artwork completed by the Circle of Hope and other members of the stolen generations can be seen in the garden. It serves as an educational resource, fostering cross-cultural respect and understanding in South Australia.

Mofflin Park, one of Playford's newest parks, is nestled within the City's health precinct adjacent to the Lyell McEwin Hospital. The reserve is designed to encourage physical activity, as well as rest and recuperation to complement growing health services nearby.

This park is currently under construction and is anticipated to be completed within the beginning of 2024.
