## **Overview of Natural Area Bushland**



Natural area bushland is of a significant value due to the flora species and composition present. Many areas have remnant areas of vegetation or land which might have been disturbed but still retains a predominance of the original species.

Council aims to protect and improve the composition of native species and take appropriate action for weed management, animal pest management and bushfire control.

These sites may also be preserved for the habitation of local native fauna and as seed sources for revegetation projects. The areas may include revegetation sites and walking trails, with interpretive signs and seating. These sites may be appropriate for native vegetation offsets and extensive revegetation works.

#### Purpose for Which the Land is Held

Natural Area Bushland areas are provided for one or more of the following purposes:

- Protection and enhancement of local native flora and fauna.
- Provide passive and recreational activities for the community and other visitors.

#### **Management Proposals for the Land**

Council will manage development and maintenance of natural area bushland in accordance with all legislative requirements and Council's strategic documents which include the Strategic Plan, city-wide strategies, the Strategic Asset Management Plan and applicable masterplans.

Council's strategic documents are updated periodically. They provide guidance for the planning, management and decision making for Council's community land. A full reference list of the legislative requirements and strategic framework documents is contained within the Community Land Management Plan (CLMP) Overview.

Any proposals which are identified for any of the natural area bushlands are subject to Council approval and available funding (external grant funding or Council financed).

Council's key strategic management objectives for natural area bushland include:

- Conservation of biodiversity and maintenance of ecosystem function in respect of the land, feature or habitat.
- Protection of native vegetation under the *Native Vegetation Act 1991* in sites where the Act applies.
- Retain, protect and enhance the natural landscape as per Council's Biodiversity Directions Report 2021.
- Protect remnant vegetation, undertake revegetation to buffer and enhance areas of natural bushland.
- To provide for passive community use of and access to the land in such a manner as will minimise and mitigate any disturbance caused by human intrusion.

#### **Description of the Land**

Within this plan a table will be included which will provide the following information:

- Name of land
- Street address
- Certificate of title, plan and allotment
- Owner of the land
- Dual category CLMP number
- Crown land trust or dedication granting the City of Playford as custodians

There may be occasions where a land parcel has been assigned multiple community land categories, referred to as "dual categories." For example, the land parcel could have a dual purpose of a natural area bushland and also a linear reserve, in these instances the land parcel would appear in both the Natural Area Bushland and Linear Open Space and Corridors CLMPs. The table contained within this plan will indicate where there are dual categories for land parcels.

Further information including lease and licence details for land parcels are referenced in the Community Land Register available on the City of Playford website.

#### **Leasing, Licensing & Permits**

General information regarding Council granting of a lease, licence and casual hire permits over community land is contained within the CLMP Overview.

Lease, licence or permit agreements may be granted which are consistent with this plan. In the case of Crown land, the agreement must also be consistent with the dedicated purpose of the land.

Granting of a lease, licence or permit must be in accordance with the conditions set out in Section 200 and 202 of the Local Government Act 1999.

Details of current lease or licence agreements are included in the Community Land Register available on Council's website.

#### **Objectives, Targets and Performance Measurement**

Council is required within the CLMPs to set out its vision for the land through objectives and performance targets, and how Council proposes to measure its performance against its objectives and targets.

Appendix A sets out the objectives, performance targets and measures for natural area bushland.
