DECOMMISSIONING OF A HIGH-RISK MANUFACTURED WATER SYSTEM (HRMWS)

ABOUT THIS FORM

Whenever a business decommissions or removes a High-Risk Manufactured Water System (HRMWS) the business must, under the <u>South Australian Public Health (Legionella) Regulations 2013</u>, notify Council within one (1) month of decommissioning the system. In order to notify Council, please complete and return page two of this form to the Environmental Health Team.

Failure to notify Council is an offence, and may result in the following penalties:

Maximum penalty: \$750

Expiation fee: \$80

PLEASE NOTE: if a HRMWS is recommissioned, or a new system is installed, the owner of the premises is responsible for registering these changes with the City of Playford within one (1) month of these changes being implemented.
