4. Conditions
<p>(a) If, in the opinion of Council or any servant or agent of Council, the plans and specifications submitted by the Application should be referred for a report to a qualified engineer to be nominated by the Council, the Council may refer the same to such engineer for his report and recommendations thereon.</p> <p>(b) If the engineer shall recommend any variation to the said plans and specifications, the recommendations shall be put to the Application and subject to its approval, the plans and specifications as so varied shall be adopted.</p> <p>(c) The costs and fees of and incidental to the foregoing reference shall be paid by the Applicant.</p> <p>(d) Council may, at its discretion, in lieu of such reference as aforesaid, or in addition to any report and recommendations received from the said engineer, amend any plans and specifications lodged by the Applicant, so as to accord with standards approved by the Council and shall notify the Applicant of such amendment and upon approval thereof by the Applicant the plans and specifications lodged as so amended shall be shown on the plan.</p> <p>(e) Without limiting the effect of Clause (d) hereof Council may require that the following conditions be included in the said plans and specifications:</p> <p>(i) All water pressure pipelines shall be laid within 1.1 metres of the property line on any roadway.</p> <p>(ii) All pipes shall be of a standard and strength as shall satisfy Council.</p>

- (iii) All pipes which shall be connected to any SA Water supply pipeline shall be of a standard and strength acceptable to SA Water, but in any case will be minimum class 12.
  - (iv) Subject to (vi) hereof all pipes shall be covered by a rubble and/or material approved by Council. Such rubble and/or material to be at least 600mm in thickness.
  - (v) The Applicant shall install to the complete satisfaction of Council, place markers conforming to Council *Standard Drawing No. 26* at intervals not greater than 350metres and at all changes of direction of the pipes and on both sides of the road crossings.
  - (vi) All pipes crossing under and across any road shall be covered by a rubble and/or material approved by Council. Such rubble and/or material to be of at least 900mm in thickness unless such requirements shall be altered by Council.
- (f) The Applicant shall construct the pipeline strictly in accordance with the provisions of the plans and specifications hereof and shall during the course of such construction, obey all reasonable directions of Council, its servants or agents in relation thereto.
- The Applicant, upon receiving notice of the approval of those plans and specifications submitted along with any amendments approved by the parties under sub-clauses (b) and (d) hereof, shall execute these requirements and if the Applicant is a Proprietary Company shall, if required by Council, also procure the execution by at least two of its Directors of a Bank Guarantee and shall deliver these presents (and if required, the form of Guarantee), all duly executed, to Council
