- The gate will be unlocked (when applicable) only when accessing the reserve for the above said purpose and locked at all other times.
- The permit is not transferable.
- No other access / activities are allowed other than the reasons indicated above.
- The Council take no responsibility for any loss by any person or association whatsoever as a
  result of any unlawful act by any person or persons that can be attributed to the access of the
  reserve.
- Lock and daisy chain to be supplied by resident / contractor.
- Council reserve the right to destroy/cut the lock, if it has not been removed as per the agreement.
