

Flying of Flags Policy

1. Statement of Intent

Flags by their very nature are the symbol of a nation, state or organisation and it is important for the Council to have regard to flag flying protocols and flag flying hierarchy.

Various flags will be flown on civic property owned by Council as an expression of Council's governance responsibilities. Care will be taken to ensure that the flags displayed are acknowledged with due diligence, dignity and attention to position. Where practicable and subject to asset capabilities, preference for flying flags will be to utilise flagpoles.

Council will have regard to flag protocols outlined in the Australian Flags Booklet – Part 2, where Council has control over the display or management of flags within the Playford area.

Community groups or individuals may lodge requests for the Council to fly certain flags to promote, acknowledge or commemorate various occasions or community events. The Mayor and CEO will consider and provide approval as appropriate for community requests to fly flags, in accordance with the criteria specified in the Flying of Flags Procedure. Community requests to fly flags should be approved where a significant proportion of the Playford community has a related interest in the cause, occasion, group or similar that the flag acknowledges or commemorates flag; and if the flag would not be deemed to cause offence to the community at large.

2. Scope

All employees and the Mayor, who undertake various duties relating to the flying of flags and banners for and on behalf of the Council must abide by this policy.

3. Legislation and References

This Policy is to be read in conjunction with the Flying of Flags Procedure.
