

Terms and Conditions

Smashing Door Prize

1. The promoter of the “Smashing Door Prize” is the City of Playford ABN 99 397 793 662 of 12 Bishopstone Road, Davoren Park, South Australia, 5113.
2. Information on how to enter and prizes for the City of Playford *Smashing Door Prize* form part of these conditions of entry.
3. The door prize draw is open to attendees aged 15+ who enter the *Smashing Door Prize* at the City of Playford Tennis International Final day event, on Sunday 3 November commencing at 11am.
4. City of Playford Councillors, employees, volunteers and their immediate families are ineligible to enter.
5. To enter, you must collect an entry form at the Playford City Tennis Centre from Sunday 10am, 3 November. Fill in the details and drop your entry form into the entry box at the venue before noon on 3 November.
6. There is one prize to be won, valued at \$50. The winner will receive 2 x Adult Ground Passes to the Adelaide International on Wednesday, January 15 (day session). Kids (aged 3 -14) go free. Coin toss will be for that day’s session (match to be confirmed when schedule is announced).
7. Winner will need to be in attendance at the Playford City Tennis Centre to collect their prize, or it will be forfeited to next drawn. There will be a maximum number of three draws, and if no one comes forward to collect the prize, it will be forfeited back to City of Playford.

Winners will be required to be in attendance to collect their prize and will be given details about how to collect their prize at time of draw.
